



XLIX International Open "CITY OF SEVILLE"

In Memoriam Antonio Sancho Miranda and Antonio Romero Mahindo From January 12 to 20, 2024

RULES

1. Participants.

Players with the ESP flag in FIDE must have a valid federation license in Spain for the tournament and foreign players must have a FIDE code before the start of the tournament. Participants have the obligation to verify their personal data, ELO and codes among others. Everyone must be registered at www.gefe.net.

2. Local game and schedule.

The tournament will be held at the Palacio de Exposiciones y Congresos (Salón Albaicín), located in Avenida Alcalde Luis Uruñuela, 1, 41020 – Seville.

The closing ceremony and awards ceremony will be on January 20 at 14:30 approximately.

3. System and pace of play.

Swiss system, according to the VEGACHESS program, 9 rounds. Complaints regarding computer pairing are not accepted, except for errors in data entry. Pairings will be considered official at 10:00 a.m., except for the last round, which will be official 2 hours after being published on the website.

The pace of play will be, for each player, 90 minutes plus a 30-second increment per play.

Analysis or reproduction of games will not be permitted in the gaming room. You may not leave the Game Room, with the game in progress, without authorization from the Arbiter.



4. Initial Order.

According to current FIDE ELO (for those excluded from the list, their last published ELO). Next, by ELO FADA and then by ELO FEDA. In equality of FIDE ELO, the best FIDE qualification will be considered and subsequently in alphabetical order.

5. Application for BYE/Breaks.

There will be up to 3 BYEs available to players (except invited players), they can be requested or canceled before the previous round begins (for example: to request a bye for round 5, it must be requested before starting round 4), applicable in the first 6 rounds of the tournament. In the requested round, the BYE requesting player will not be paired and will be awarded half a point. In all requests the final decision is made by the chief Arbiter based on the proper development of the competition, taking into account the number of points and/or the existence of non-appearances.

6. Delays, defaults and disqualifications.

A maximum delay of 60 minutes is allowed, counting the time from the official start time of the game.

The player who does not show up at the beginning of the first round may be replaced by another participant and will be excluded from the tournament. The failure of a player to appear in a round will cause his disqualification, unless he requests in writing to continue, before the pairing for the next round is published.

It supposes definitive disqualification: the accumulation of two non-appearances, justified or not.

7. Table Agreements.

In addition to what is provided in the Laws of Chess, players will only be able to agree on a draw when each of them has made at least 30 moves.

The agreement of a draw before 30 moves will be subject to the arbiter's consent.

8. Electronic devices.

Unless expressly authorized by the arbiter, the use or carrying of any electronic device is prohibited in the tournament room during matches. Such devices are permitted to be stored in players' bags, as long as the device is completely turned off. This bag must be placed in the place assigned by the Arbiter, players are prohibited from using this bag without the Arbiter's permission. Failure to comply results in the loss of the game. Neither the organization nor the Arbiters are responsible for the safekeeping and custody of electronic devices.

9. Annotation of the games.

Players have the obligation to deliver the original signed scoresheet with the correct result to the arbiter at the end of the game. The plays will be noted in as clear and legible a way as possible, algebraic notation. Remember that with this pace of play you cannot stop scoring at any time.





10. Valid for ELO.

The tournament will be valid for obtaining the title and ELO FIDE, FEDA and FADA classification standards, in accordance with current regulations.

11. Tiebreakers.

The following tiebreaker systems will be applied (games not played will be governed by the provisions of FIDE C.07).

- a) Bucholz minus the worst result
- b) Medium bucholz
- c) Average rating of rivals (ARO)
- d) Highest number of wins
- e) Sweepstakes

12. Conditions of play.

Players have the right to decent, regulatory and comfortable playing conditions; to fair and respectful treatment by the Organization and the Arbiters; to sufficient services; to complete general sports information about the tournament; to specific information on title results; and have open access to the playing area 30 minutes before the start of the round.

13. Conditions for participation.

To participate in the tournament, you must accept the publication of images and personal data (name, surname, year of birth and sports data), in different media, for the necessary dissemination and promotion of the event (lists of results, classifications, participants, games, ...). Participants will be required to sign this authorization before starting the tournament.

The tournament will be governed by the FIDE Chess Laws in force. Registration in the tournament implies acceptance of these rules and the pairing program used.

These rules may be briefly modified before the start of the tournament.

14. Competition and complaints committee.

The Competition Committee will be made up of the Tournament Director, with a casting vote, and 4 regular players and 2 substitutes. Only those born before 2006 and with a FIDE Elo greater than 1700 may be part of the committee. Firstly, they will be chosen from among the players who are certified Arbiters. If these are less than 6, everyone will become part of the committee and the other places will be chosen by lottery among the remaining players. If there are more than 6, it will be chosen by lottery.

A decision of the Chief Arbiter may be appealed to the Competition Committee, in writing, within 15 minutes following the end of the game in question, under the terms authorized by the Laws of Chess. Sanctions outside the game, decided by the Chief Arbiter, are also appealable within 15 minutes of their notification. Complaints to the arbitration decisions may be presented to the committee at the end of the game about which the claim is raised and a deposit of €50 must be delivered to the organization, which will be returned only if the committee favorably resolves the claim.





15. Inscriptions.

The following registration fees are established:

- General Fee 55€
- Player Fee (Andalusian Federation) 45€
- Player Fee (Sevillian Delegation) 35€
- Children's Fee (year 2010) 25€
- Sportsman with a disability (33%) 10€ discount on the corresponding fee.
- Titleds **WFM y FM** 35€* / **WIM, IM, WGM, GM** Free

<u>Titleds (WFM, FM):</u> WFM and FM graduates must pay €35 as a deposit, which will be returned once the tournament is over, as long as they have completed the tournament.

<u>Cancellations</u>: They can be requested until 08/01/2024, the registration amount will be refunded by transfer, minus 50% for administrative and management expenses.

<u>Groups:</u> €5 discount per participant, for clubs registered in groups with more than 10 registrations. The refund will be made by transfer, once the tournament is over, if the players have played at least 50% of the games.

The registration deadline is 08/01/2024 and will be done through the website: **www.gefe.net** in its public part by clicking on registration. A drop-down menu must open with the list of available tournaments – **Seville Open 2024**.

16. Prizes.

The prizes are not distributed, they are awarded in strict order of classification including tiebreakers, first they are awarded general, then local and finally ELO sections. If you opt for two prizes, you receive the one with the highest amount. When the amount is the same, the order of assignment is 1st General, 2nd Sections, 3rd Categories and 4th Local. In the prizes by ELO sections, the FIDE ELO of the player will be taken, in case of not having FIDE ELO the FADA will be taken into account. In any case, the highest ELO in effect at the start of the tournament will count. The withholdings established by current legislation will be applied to all prizes (15% for Spanish players and 25% for foreign players) and will be paid by bank transfer.

Players federated in the Sevillian Chess Delegation and who have accredited residence in the province of Seville during the 24 months prior to the competition are entitled to local prizes. Children (U14) are considered those born in 2010 and later, Youth (U18) are those born between 2006 and 2009. Veterans (Supra50) are those born between 1960 and 1974, Veterans (Supra65) arethose born in 1959 and earlier.
